COUNTY ACTIONS/DISCUSSION

June 4 Meeting

Canceled due to lack of Business Items

June 18 Meeting

- 1.) Had the honor of reading the Juneteenth Day Proclamation into the record and offering it into the agenda.
- 2.) Approved the appointment of Mr. Tino Smith, PHD to the Calhoun County Jury Board.
- 3.) Motion to approve a waiver of Policy 509 (return to gravel policy) for Leroy Township failed 3-4 (Tompkins, Smith, Miller & Hatcher dissenting). No residents on the road identified had been contacted & the township board did not want to take a position. The provision in the policy was created to build collaborative relationships with township boards so they could have a say in turning roads back to gravel which was much appreciated by the township boards. This waiver would have compromised the integrity of the policy and set a precedent. Although ACT 51 does state that counties have the ultimate responsibly of roads, having a collaborative relationship with township boards is important. As a result of this good relationship building, the new 50/50 share policy has seen a significant increase in participation. The CCRD budget had called for \$700k in road share and to date the county has seen \$1.08 million in sharing. Good policy brings good results.
- 4.) Approved (7-0) the letter recommendation from the Senior Millage Allocation Committee to President Trump regarding COVID-19 affect on seniors and ideas to improve the Federal Govt. response.
- 5.) Approved (7-0) the Calhoun County financials for May 2020. Admin Scott stated that the finalization of the 2019 budget will be next week and based on COVID-19 having an impact on the 2020 budget., the county see as much as a \$2 million shortfall. The budget will be closely monitored by Admin Scott and Finance.

OTHER HAPPENINGS

- 1.) Participated in a mental health virtual meeting on June 2. Meagan Taft of Summit Pointe discussed issues surrounding mental health and I had the opportunity to present on the 2021 Federal Drug Free Community Grant. The Albion-Homer Substance Abuse Prevention Services Coalition has put together a grant committee that I co-chair to work on bringing additional resources to the area focusing on our youth.

2019 Calhoun County Transportation Study Results

The proceeding are some introductory details regarding the Transportation study that was recently completed by an outside consultant through a grant received by the MDOT.



Two Governance Options were proposed:

- 1.) Creation of separate public authorities for Urban and Non-Urban sections of the County
 - * Similar to Kalamazoo County
 - * This option would require 70 FTE's
 - * This option would provide a savings of \$390K and would benefit both entities and the public by reducing redundancies.
- 2.) Creation of a Public Authority for Countywide Demand Response Service and continued operation of Battle Creek Transit Fixed-Route service per status quo.
 - * Battle Creek Transit would remain a department of the City of Battle Creek.
 - * This option would require 75 FTE's

Qualitative Benefits of Governance Alternative #1

In addition to cost savings, operational integration would have the following benefits:

- More comprehensive and streamlined planning, resulting in better coordination of services
- Easier process of establishing and running the new CCTA i.e., the ability to take advantage of BCT staff's collective decades of experience and institutional knowledge in operating transit, federal compliance, etc.
- A service providing travel between Battle Creek and other communities bringing employees and shoppers to Battle Creek, and giving Battle Creek
 residents access to jobs and services in other communities
- BCATA could remain the designated recipient for federal and state transit funding, and both entities would have access to more diverse funding
- Consolidation is supported and encouraged by MDOT.
- The authorities could create millage districts for more sustainable funding for transit service.
- Potential promotion of existing transit services in Battle Creek as part of a countywide branding strategy (more visibility, awareness of the value of transit service, leading to greater usage and local support).

Preliminary Timeline (Implementation Plan)

Short Term (2020-2021)

- * Continued integration of transportation services.
- * Preparation for new authority and est. of CCTA brand.

Long Term (Beyond 2024)

* Consider expansion, on-going service planning

NOTE: Est. Millage would be .389 mills

Mid-Term (2022-2023)

- * Est. authorities & designate as funding recipient.
- * Implement policies regarding trip request priorities & fares .
- * Negotiate & carry out asset lease and/or transfer agreements.
- * Hold referendum on millage funding for public transit.
- * Expand services to gen. public in participating jurisdictions.
